SKI HOLIDAYS 2025 BOOKING CONDITIONS & RELEASE OF LIABILITY

DEPOSITS

A minimum deposit is required at time of booking your Ski Holiday of \$1000.00pp plus payment for flights and land if required. Bookings will only be accepted with the signed Booking Form and the appropriate deposit.

PROGRESS PAYMENTS

Deposits due within 5 days of Booking with final payment due October 2023 for Ski Holidays, dates will be advised.

AMENDMENTS

A confirmed booking may incur charges for change, unless if involves a cancellation fee. Third Party amendment fees may apply also.

COSTS

The advertised tour cost is expressed in Australian dollars, based on costs, charges, fares, tariffs and currency exchange rates at the date of issue and are subject to change with or without notice. Tour cost & group rates are calculated on a minimum of 25 participants, with payment by cash, cheque or direct deposit to Estours Commonwealth Bank account. Tour cost may vary if minimum group size is not achieved. Payments by credit cards will incur a fee. This tour is a complete holiday package and itemization of costs will not be rendered.

CANCELLATION

Airfares are subject to cancellation fees of up to 100%. All cancellations irrespective of date of cancellation will incur a minimum fee of \$250 per person. Cancellations prior to departure incur a fee dependent on time of cancellation. Land package cancellation policies vary depending on charges levied by the hotels, transport companies and service providers, and third party booking agents which can be as high as 100% of travel cost.

INSURANCE

We strongly recommend you take out travel insurance to cover cancellation charges, personal accidents, loss or damage to luggage, medical expenses, evacuation and personal liability. If you decline to take out travel insurance, we will require you to sign an indemnity form. Should you obtain insurance separately then Estours Travel will require a copy of the policy and contact details for use by our tour leader, if necessary.

BAGGAGE

Free baggage allowance depends on your airline, up to date information will be found on the airline websites. Check with your airlines for allowances for ski and sporting equipment..

TRAVEL DOCUMENTS

All passengers departing Australia need valid passports. You may need a re-entry permit to Australia if you are traveling on a passport of another nationality. The validity of a passport must extend at least 6 months past the return date to Australia. It is the passenger's responsibility to ensure that they are in possession of the necessary travel documentation and that they comply with the appropriate government and transportation regulations. Online Visa waivers may be required for travel to Canada and the US.

COSTS DO NOT INCLUDE:

Passport and visa fees, airfares (except as specified), fuel surcharges and airport taxes, excess baggage charges and all other costs of a personal nature, not specifically included. Reservations - Deposit and Balance Payment A Booking Form must be received by Travelplan Ski at time of deposit to proceed with booking. A ground package deposit of 10% of cost plus any lodging deposit is payable at booking. Higher deposits up to 50% can be required by some hotels and apartments. Balance payment is 60 days prior to departure, or according to airline, lodging and other principal rules. Christmas bookings generally have to be finalised by October.

Credit Card Payments Surcharges apply, which vary by card type. Credit card payments are accepted on the express understanding that you authorise Travelplan Australia PtyLtd to pay deposits and balance payments on your behalf to airlines, accommodation operators and other principals involved. Baggage Allowance We recommend prior to departure, you check exact baggage restrictions with the airlines on your itinerary. The following information is given as a guide, but is subject to change. Domestic flights often do not include free checked luggage, particularly in the United States. Airlines may waive baggage charges on domestic flights if you are connecting to/from an international flight, or upon presentation of your international ticket at the checkelin counter. If more than one airline is providing the transportation for journey, each airline may apply different rules on both checked and carry-on luggage.

Generally speaking, for direct flights from Australia to North America, two subcases are allowed with a combined total dimension of 106 "(269cm) with no one subcase exceeding 62" (157cm), with max 23kg for Econom y/Premium Class or 32kg for Business/First Class per piece. For international flights elsewhere free baggage allowance is generally 20kg total for Economy Class, 30kg for Business Class and 40kg for First Class. Maximum 1 piece per person carry on luggage. All carry on luggage must comply to size restrictions enforced by the alfilnes and generally a piece must not weigh more than 7 kg.

Pas sport and Visa A passport is required for overseas travel, with a validity of six months after your return date. For some countries a consular visa or travel authorisation is also required. We will advise re obtaining necessary travel documents and advise on health regulations. However, the possession of such documents is solely the passenger's responsibility.
